**ORDINANCE NO: 2013-21**

**AN ORDINANCE AMENDING SUBSECTION 250.13 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF BENTLEYVILLE ENTITLED LIFE INSURANCE AND DECLARING AN EMERGENCY.**

**WHEREAS**, Council for the Village of Bentleyville desires to amend subsection 250.13 entitled Life Insurance.

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Bentleyville, County of Cuyahoga, State of Ohio, the following subsection shall be amended to Codified Ordinance 250.13.

**Section 1.** That subsection 250.13 of the Village of Bentleyville Codified Ordinances entitled "Life Insurance" which previously read as follows:

**250.13 LIFE INSURANCE**

Each full-time employee is covered by a twenty-five thousand dollar (\$25,000.00) minimum (or one times the annual base pay, whichever is greater) individual life insurance policy with double indemnity for accidental death or dismemberment. This insurance is provided at no cost to the employee and employees become eligible for employee insurance upon completion of 30 days of continuous full-time employment.

**BE AND THE SAME IS HEREBY AMENDED TO READ AS FOLLOWS:**

**250.13 LIFE INSURANCE**


Each full-time employee is covered by a twenty-five thousand dollar (\$25,000.00) minimum individual life insurance policy with double indemnity for accidental death or dismemberment. This insurance is provided at no cost to the employee and employees become eligible for employee insurance upon completion of 30 days of continuous full-time employment.

**Section 2.** This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, or safety of the inhabitants of the Village and for further reason set forth in the preamble hereof, and this Ordinance shall, therefore, take effect and be in full force immediately from and after the date of passage and approval.



**WHEREFORE**, this Ordinance shall take effect and be in force from and after the earliest date permitted by law.


